**Conclusion**

## MONACO STATE OF MAXIMUM ALERT

Following the Nice terror attack

On the 14<sup>th</sup> of July 2016, France was struck by an Islamist " lone wolf " inspired by Daesh, causing 83 deaths and as many again injured. Once our disbelief, sadness and our condolences had been conveyed to our French neighbour by the sovereign, head of state and the royal government, the Public Safety Authority in the Principality of Monaco declared a state of maximum alert and a crisis unit was set up from within the Ministry of the Interior.

In solidarity for and support to the French people, several demonstrations have been cancelled in Monaco and a mass has been held in memory of the victims at the Cathedral of Monaco in the presence of members of the government and the royal family. It is obvious to the authorities that a similar terror attack cannot and must not happen in Monaco.

But how is it to be avoided, how do we prevent it and what measures must be taken to ensure such an event does not happen.

It is true that Monaco, only 2 square kilometres in size, is not a target for Islamists. However, a lone fanatic radicalised and inspired by the sound-bites of the type spread by Daesh, could be tempted to see the principality as a target.

From there on the limits of the territory can be an advantage as they allow the creation of all sorts of plans and theories for attack, which in turn keeps the entire police force on the alert, with numerous and varied means at their disposal for protecting and reassuring residents while at the same time anticipating as much as possible what could happen.

Thus police presence at the four entry points of the principality has been strengthened. All vehicles entering the territory are scrutinised without necessarily being stopped. Faces are examined and their potential for being dangerous evaluated by specialists, vehicle control having been reinforced intra muros. Anything suspicious is verified and the police force increased and armed with assault weapons, ready to react to any threat. Access around the Casino and the Rock of Monaco has been restricted to certified vehicles only.

Vehicles can no longer stop unexpectedly at heavily frequented places, because they could represent a possible target. Security at establishments in the vicinity of the Casino has also been visibly reinforced. Security agents have been placed at the entrances to the Hotel de Paris, the Casino and the Café de Paris. Bags are checked and/or scanned and police presence supported by army backup.

Even access to the Beach of Monte-Carlo, the famous high-class beach of Monaco, although located on French territory, has been made a secure zone and its access strictly controlled.

The maritime area has also been reinforced in order to avoid the possibility of an arrival from the sea.

Everything has been set up to limit as much as possible from now on, any attempt of the kind that happened at "la Promenade des Anglais", in Nice.
